On December 16, Nexwsxwníwntm ta Úxwumixw (Council) approved the workplan and timelines to develop a Wa Lhkwáyel Skwiyíńtsut (Climate Action Strategy). Building a sustainable and resilient community in the face of climate change is something that the Nation has been working towards since declaring a climate emergency in 2019.

Over the next two years, Ta na wa Yúus ta Stitúyntsam (Rights & Title) will lead the development of the climate strategy. With input from the community, it will set out priorities and specific actions to protect and strengthen the rights of our people, protect quality of life, and enhance the health of our community. It will also contribute to the global goal of net zero emissions by 2050. The Wa Lhkwáyel Skwiyíntsut will be a living document, updated and revised every five years.

Share your thoughts on the role that Skwxwú7mesh culture and values can play in developing solutions to the climate crisis. Nexwsxwníwntm ta Úxwumixw (Council) Committees Created for 2021 - 2025 Term

Nexwsxwníwntm ta Úxwumixw continued its onboarding activities over November and December by restructuring Council Committees for the new term and selecting Councillors to sit on them. The reorganization will aid Nexwsxwníwntm ta Úxwumixw in performing its duties more effectively. For the first time, non-voting external appointees will sit on two committees (Rights & Title Advisory Board and Finance & Audit Committee) to bring additional expertise and knowledge.

On December 2, seven committees and one advisory board were created. Each is comprised of a maximum of three Councillors. Therefore, each Councillor is a member of up to three Committees. The Chairperson and Band Manager sit on each Committee as ex-officio members (meaning they cannot vote) and attend meetings if or when needed.

Each committee will select a Chair and Deputy Chair in February 2022 and hold initial meetings in March. They will also develop a Terms of Reference. All Council Committee minutes will be available to Membership through the Members only section of the website.

Budget & Strategic Priorities Committee

Purpose: To advise on the development and implementation of the Strategic Plan and its alignment with the annual budget process, and the development and implementation of the Comprehensive Community Plan.

Community Services Committee

Purpose: To advise on matters involving services and community including Member Services, Language & Cultural Affairs, Health & Wellness, Child & Family Services, Planning & Capital Projects, Education, Employment, & Training, Community Operations, and Public & Community Safety.

Purpose: To provide advice on policy review and development, and oversight of the implementation of the policy framework.



Rights & Title Advisory Board

Purpose: To provide strategic advice to the Ta na wa Yúus ta Stitúyntsam (Rights & Title) Department and Nexwsxwníwntm ta Úxwumixw on matters including environment, climate mitigation & adaptation, archeology, natural resources, and government-to-government relations.

On December 10, 2021, the Skwxwú7mesh Úxwumixw announced it signed a Memorandum of Understanding (MOU) with səl ilw əta? (Tsleil-Waututh), xwməθkwəy əm (Musqueam), and Lil wat7úl (Lil'wat) Nations to explore a potential Indigenous-led bid for the 2030 Olympic and Paralympic Winter Games. The City of Vancouver and Resort Municipality of Whistler were invited to join the four Host Nations in this exploratory review.

This is not yet an official bid for the Games. It is an opportunity for the four Nations to assess both the positive and negative aspects of hosting, as well as explore available funding opportunities. Once the full picture is understood, a recommendation will be made whether to present a formal bid.

This would be the first Indigenous-led bid in the history of the Games and, if successful, would be a major step towards Reconciliation through sport. It would be an opportunity to announce to the world that we are not invisible, we are still here and will always be here. The four Host Nations proudly

welcomed the world for the 2010 Vancouver Games, playing a key role as they took place on our shared territories. For the 2030 Games the Host Nations, and their Members, would take on the lead role in all aspects of planning and hosting.

As the process continues, more information will be shared with community on the Nation's social media channels and at squamish.net/olympic-mou.

"We call upon the officials and host countries of international sporting events such as the Olympics, Pan Am, and Commonwealth games to ensure that Indigenous peoples' territorial protocols are respected, and local Indigenous communities are engaged in all aspects of planning and participating in such events." – Truth and Reconciliation


