



syétsem tl'a syelánm (Annual Report) 2021/2022 Published



Nexwsxwníwntm ta Úxwumixw (Council) approved syétsem tl'a syelánm 2021/22 on tem p'í7tway (October) 6, 2022 in accordance with the Financial Administration Bylaw 2019.

syétsem tl'a syelánm presents the Nation's successes and challenges and reports on the operational and financial performance of the past year. Our people slowly started coming together again and returning to our Skwxwú7mesh ways of being as we got vaccinated and restrictions eased. The Nation delivered services and programs to Members while making progress on the four visions of Skwxwú7mesh Úxwumixw 2026, our Strategic Plan.

Snagging and Treble Hook Fishing Ban

Skwxwú7mesh Úxwumixw 2026 – our Strategic Plan – outlines the importance of protecting the fisheries and marine habitats that support our Skwxwú7mesh way of life. We are concerned about the decline in wild salmon and other fish in our waters.

As a conservation measure, Nexwsxwníwntm ta Úxwumixw (Council) passed a resolution for the immediate ban on all snagging and treble hook fishing at the Cheakamus Frog Pond and Moodyville fishing sites.

This new ban replaces a 2017 resolution where snagging and treble hook fishing could only take place on weekends. Snagging and treble hook fishing is now banned seven days a week, 24 hours a day. The ban will be reviewed annually and remain in place until salmon populations return to sustainable levels.

Modular Primary Care Clinic for Squamish Valley

To provide Squamish Valley Members access to medical services closer to where they live, Nexwsxwníwntm ta Úxwumixw (Council) passed a resolution on tem p'í7tway (October) 6, 2022 to construct a modular clinic at Siýích'em.

As the next step, Ta na wa Shéway I7xw ta Úxwumixw (Planning & Capital Projects) and Yúustway (Health & Wellness) will develop a Business Case. A budget will be developed, additional design work will take place, and there will opportunities for Members to provide feedback. More information will be shared as the project progresses.

The First Nations Health Authority (FNHA) has generously committed \$500,000 towards the construction of the modular clinic. This clinic is one step along the path to providing Squamish Valley Members with comparable medical services to those on the North Shore. Yúustway, with support from Ta na wa Shéway I7xw ta Úxwumixw, will also conduct a Needs Assessment for the development of a larger healthcare center.
