PARK ROYAL CULTURAL STRATEGY

On July 2, Council approved the work plan, budget, and terms of reference for the Squamish Nation Arts & Culture Strategy Project at Park Royal. (See the 2019 Q1 Quarterly Report from Council for background on the project.)

A working group—comprised of members from the Squamish Nation Language & Cultural Affairs Committee, Squamish Nation members, Larco/Park Royal representatives, and a consultant—will be formed to provide input, advice, and recommendations on the Squamish Nation Cultural Strategy and Partnership.

Once formed, the working group will host two community panel workshops to discuss and examine Squamish Nation language, culture, and heritage opportunities at Park Royal along with visitor attraction(s) while considering economic, social, and employment benefits for the Nation.

Following the workshops, the consultant will deliver a final report with recommendations to Council.

SOUAMISH LANGUAGE POLICY FRAMEWORK ENGAGEMENT

On July 2, Squamish Nation Council approved a draft Language Policy Framework for discussion purposes.

The founding provision of the Squamish Language Policy Framework is a recognition on the language rights of the Squamish Peoples including reference to the United Declaration on the Rights of Indigenous Peoples, Section 35, and others.

The draft Policy Framework includes a mandate to create a language authority called a Language Commission to be appointed by Council. The Commission will be comprised of nine members for a four-year term based on specialized language-related criteria.

Other highlights of the draft Policy Framework include a mandate to develop an official language revitalization strategy, an oral proficiency certification, and an official Squamish Language Commission Teaching Certification.

Feedback on the draft Language Policy Framework will be solicited from Squamish Language speakers, Language & Cultural Affairs staff, Squamish Nation elders and youth, language teachers, and Squamish Nation members. Staff will summarize the feedback into a report on key themes, suggestions, and ideas, and return to Council with a draft policy and implementation plan for consideration by Council.

CLIMATE EMERGENCY

On July 16, Council passed a motion declaring, in part, that, "the breakdown of the stable climate and sea level under which human civilization developed constitutes a climate emergency."

The threat of climate change has been at the forefront of leaders' minds around the world in recent years. On April 22, 2016, world leaders from 175 countries recognized the threat of climate change and the urgent need to combat it by signing the Paris Agreement, agreeing to keep warming "well below 2°C above pre-industrial levels" and to "pursue efforts to limit the temperature increase to 1.5°C," which is in itself not safe for humanity. Then, on October 8, 2018, the United Nations released a special report which projected that limiting warming to the unsafe 1.5°C target this century will require an unprecedented transformation of every sector of the global economy over the next 12 years, which was criticized by many

leading climate scientists as overly conservative.

As part of the motion passed, Council mandated the formation of the Climate Emergency Committee—comprised of Councillors Kristen Rivers, Chris Lewis, Joyce Williams, Dustin Rivers and Deanna Lewis—as a Standing Committee under the Governance Policy. The Committee will return to Council with a Terms of Reference to assist Council and the Nation in responding to the Climate Emergency.

Effective immediately, the Squamish Nation will begin advocating to all levels of government and in First Nations political organizations for climate action that meets the requirements for a stable climate as outlined in the Intergovernmental Panel on Climate Change (IPCC) Report to reduce Canada's carbon emission by 60% below 2010 levels by 2030 and to achieve net zero emissions by 2050.

EDUCATIONAL JURISDICTION

On July 5, 2006, First Nations, Canada, and BC signed an Education Jurisdiction Framework Agreement. This agreement sets the overall context and road map for implementing First Nations' jurisdiction over education in BC. The education jurisdiction initiative provides formal recognition by the Federal and Provincial governments of a First Nation's right to make decisions about the education of its children through signed agreements. BC First Nations have been seeking recognition of their jurisdiction over education for decades.

Educational jurisdiction brings a First Nation's exercise of jurisdiction to life and sets the scope of its law-making powers. It also recognizes a First Nation's jurisdiction over education on First Nation Land (i.e., reserve land). It is worth noting that Educational Jurisdiction must be ratified by a majority of eligible voting members of a Nation.

In order to become self-governing in the area of Educational Jurisdiction, the Squamish Nation has two options for joining the process: become an "Interested First Nation" (IFN) or a "Negotiating First Nation" (NFN). As an

IFN, the Squamish Nation would be invited to attend Education Jurisdiction Meetings from time to time. This would enable the Nation to be informed about the education jurisdiction process and influence the process by providing recommendations. As an NFN, the Squamish Nation would attend NFN meetings where the education jurisdiction process is directed, as well as Education Jurisdiction Meetings.

In July, Council received a presentation on the Education Jurisdiction process, and voted in favour of becoming an Interested First Nation. Further, Council directed the Directors of Education, Employment & Training, Language & Cultural Affairs, and Finance to jointly develop a work plan, budget, and recommendation for proceeding with becoming a Negotiating First Nation to present to the relevant Committees of Council before it is presented to Council in early 2020.

SKWXWÚ7MESH RIGHTS & TITLE DEPARTMENT INTERIM POLICY FRAMEWORK

The newly-formed Rights & Title Department, in conjunction with the Rights & Title Committee of Council, has developed an Interim Policy Framework to govern the conduct of many of the Department's key functions and support a smooth, transparent transition for the new Department. The Rights & Title Department is responsible for the important roles of asserting, protecting, and leveraging (for benefits) the Squamish Nation's right and title interests in its traditional territory.

The Skwxú7mesh Rights and Title Department Interim Policy Framework, which was approved by Council on September 10, 2019, contains the following components:

- 1. Policy Purpose and Principles
- 2. Departmental Mandate
- 3. Departmental Functions

 Under the oversight and direction of the Squamish Nation Council Rights and Title Committee, the Department is responsible for performing the following functions related to advancing the growth, strength, and implementation of Squamish Nation Rights and Title.

- 4. Squamish Nation Rights & Title Strategy The Department will develop and maintain a Squamish Nation Rights and Title Strategy, which will set out the Department's broad approach to advancing the growth, strength, and implementation of Squamish Aboriginal Rights.
- 5. Department Structure and Staffing- includes clear staff positions and roles/responsibility descriptions that ensure clarity, certainty and accountability of staff.
- 6. Referrals process Clearly outlines the process for receiving, processing, responding to, and developing an action plan in relation to, incoming referrals and correspondence.
- 7. Accountability to Council

 clearly establish clear
 direction to staff with
 respect to when and how
 the Department should be
 reporting to Council and/
 or relevant committees
 of Council. This includes
 direction and role of the
 Aboriginal Rights & Title
 Committee.

- 8. Communication between departments establish clear guidelines for coordination between departments.
- 9. Annual Plan and budget provide direction to staff on budgeting and other accounting issues.
- 10. Departmental Budget,
 Approval of Expenditures and
 Capacity funding establish
 guidelines on expenditures
 based on the annual plan
 and approved budget. It
 also provided direction for
 staff acceptance of capacity
 funding on the Nation's
 behalf and for use of such
 funding.
- 11. Accounting provides direction on maintenance of a comprehensive and complete records system in respect of all Department revenue, expenditures or other financial transactions, including funding received from external sources. Also that the Department will be subject to financial audit from time to time.
- 12. Conflict of Interest –provide clarity around conflict of interest and processes on how to deal with such matters when they arise.

BC FIRST NATIONS GAMING REVENUE SHARING



In February 2019, the Province of British Columbia announced its commitment to share 7% of net provincial gaming revenues with First Nations over the next 25 years (totaling an estimated \$3 billion).

An interim BC First Nations Gaming Revenue Sharing and Financial Agreement was finalized on August 2, 2019, providing for the first two years of gaming revenue payments to be shared with Eligible First Nations across British Columbia. The Province and First Nations Gaming Commission are currently working to finalize a long-term revenue sharing agreement.

The First Nations Gaming Revenue Sharing Partnership (the "Partnership") has been established to receive and distribute gaming revenues to Eligible First Nations. All Eligible First Nations in the province may become Limited Partners of the Partnership and shareholders of the General Partner (the BCFN GRS GP, Inc., which manages the Partnership), and in doing so become entitled to share in provincial gaming revenues.

Following a legal review of the terms of the Partnership, the Squamish Nation Council signed a BCR on September 17 authorizing a Joinder Agreement for the Squamish Nation to become a Limited Partner.

Distributable income from the Partnership the Squamish Nation will receive is to be used for approved purposes, which are: (a) health and wellness; (b) infrastructure, safety, transportation and housing; (c) economic and business development; (d) education, language, culture and training; (e) community development and environmental protection; and (f) capacity building, fiscal management and governance of Eligible First Nations and territories and members. The agreement prohibits per capita distributions of the funds to membership.

PEAK HOUR CHANGES TO LIONS GATE BRIDGE ACCESS

At the request of Squamish Nation Council, the District of North Vancouver (DNV) has extended rush hour turning restrictions from Lower Capilano Road onto Marine Drive. This restriction, which came into effect in mid-September, is intended to discourage non-resident through-traffic from using Welch Street and Lower Capilano Road as a by-pass for congestion at Marine Drive.

The DNV has recently installed new signage. With the changes, there will be no left turns from Lower Capilano Road to Marine Drive (northbound to westbound movements) from 7:00 am–9:00 am, and from 3:00 pm–6:00 pm. Previously, left turn restrictions were in place for morning peak hours only.

The left turn restrictions are enforceable under Section 125 (Disobey Traffic Control) or Section 161 (Disobey Traffic Device) of the Motor Vehicle Act. Drivers who fail to comply with the turning restrictions are subject to a \$121 fine plus two points on their driving record.

The increased turning restrictions were a recommendation of the Capilano IR No. 5 Transportation Study, and are aimed at decreasing rush hour traffic through the Capilano reserve. The Study was prepared for the Nation with input from Capilano residents and Nation members.

Over the years, the Squamish Nation has seen a steady increase in commuter traffic trespassing through the Capilano reserve, which is putting our community's safety at risk. By introducing these new restrictions on left-turns from the reserve onto Marine Drive, the Squamish Nation is taking steps to address safety concerns and help to ensure the protection of our members and their families.

- (g) advice that is subject to solicitor-client privilege, including communications necessary for that purpose;
- (h) information that is prohibited from disclosure by provincial and federal legislation; and
- (i) sensitive intergovernmental negotiations or relations;
- (j) sensitive financial or economic negotiations; or
- (k) sensitive Squamish language, cultural heritage, or intellectual property matters.
