On October 1, 2020, Squamish Nation Council confirmed its support for the Howe Sound Biosphere Region Initiative Society (HSBRIS) bylaw amendment, which required a member of the Squamish Nation to sit as Co-Chair on the HSBRIS Board. Council is pleased to announce the appointment of Councillor Joyce Williams as the Nation's representative for this role.

In 2019, Council voted in favour of supporting the Howe Sound Biosphere Region Initiative, pending a technical review by the Rights & Title Committee and Squamish Nation staff. A letter of support drafted by the Rights & Title Department confirmed that the initiative will not affect the Nation's rights and title interest in its territory, reconciliation processes, or decisions regarding land and/or resources, and that the Biosphere Region designation is underpinned by the United Nations Declaration on the Rights of Indigenous Peoples (the UN Declaration).

The Nation is excited to be a part of this important initiative, and looks forward to helping steer it towards success.

Squamish Nation to Review Impact of Bill 41 and Alignment with the UN Declaration

On October 1, 2020, Squamish Nation Council requested that the Rights & Title Department work with legal advisors Miller Titerle + Co to review the opportunities and impact resulting from the provincial government passing legislation to implement the United Nations Declaration of Rights of Indigenous People (the UN Declaration).

In 2019, the Squamish Nation endorsed the *Declaration on the Rights of the Indigenous Peoples Act* (Bill 41), which was introduced by the Province of B.C. the same year. The adoption of Bill 41 will fundamentally change how Nation departments, programs, and staff interact with the provincial government. The work that Council has asked the Rights & Title Department and Miller Titerle + Co to do will provide the Nation with the knowledge needed to make the renewed collaboration and relationship successful.

The UN Declaration emphasizes the Indigenous peoples' rights to live in dignity, to maintain and strengthen Indigenous institutions, cultures and traditions, and to pursue self-determined development, in keeping with Indigenous needs and aspirations. The Squamish Nation supports the UN Declaration being implemented by all levels of government.



On November 12, 2020, Squamish Nation staff and consultants presented Council with the final version of the Siyich'em Reserve/Eagle Viewing Area Dike Master Plan (the Plan). Squamish Nation Council approved the Plan and directed staff to work with the District of Squamish to implement it.

The dike will be constructed on a new alignment northwest from Siyich'em Reserve 30 metres from the active Squamish River bank, and will connect to the existing dike at Fisherman's Park. This will allow the Nation to recapture lost reserve lands.

While the new dike alignment will partially disconnect a large, forested gravel bar island from the Squamish River, some connection will be maintained through a fish-friendly pump station at the outlet of Jimmy Jimmy (Judd) Slough.

As part of a separate ongoing project, the District of Squamish and Squamish Nation are planning to reconnect the upper end of Jimmy Jimmy (Judd) Slough with the Squamish River using a new culvert and gate system to improve water quality and aquatic habitat. More information will be shared with the community as it becomes available.

Squamish Nation to Explore Temporary Modular Housing

On November 12, 2020, Squamish Nation Council directed Nation staff and the Hiýám Housing Society to explore the development and management of a modular housing project. They have been asked to gather information on potential on-reserve locations, as well as construction and operational funding requirements.

Temporary modular housing can be built quickly and has the potential to provide immediate relief to Nation members who are homeless or at risk of homelessness. This project is aligned with the Squamish Nation Strategic Plan to work towards every Skwxwú7mesh being housed within a generation (defined as 25 years).

Hiýám Housing Society and Nation staff will present their initial findings to Council in spring 2021 and more information will be shared with the community after the details have been reviewed. If a project is approved to move forward, the Nation would apply for funding under the federal government's new Rapid Housing Initiative.

Squamish Nation Trustees Appointment and Development of a Trust Appointment Policy

On December 3, 2020, Squamish Nation Council reappointed Bradley Raymond Baker – Tsúnumut, and Kathleen Smith – Súseliya, as Trustees of the Squamish Nation Trust. Their term ends September 30, 2024.

They are two of the four Trustees. Tyler Baker and Chief Leanne Joe – Sxwpílemaat Siýáṁ are appointed from December 11, 2018 to September 30, 2022. Lisa Peterson is appointed as an alternate for the same period, in the event that one of them is no longer able to be a Trustee.

On December 3, 2020, Council also requested that staff develop a Squamish Nation Trust Appointment Policy to assist in the following:

- Application process;
- Selection process;
- Selection criteria;
- Scoring method;
- Vacancy process;
- Policy review schedules; and
- Any other relevant areas of the Squamish Nation Trust as per the Trust Agreement.

Staff will provide Council with a draft Trust Appointment Policy for consideration in summer 2021 and more information will be shared when available.

The Squamish Nation Trust was established in 2001 as a result of the Kitsilano Court Case settlement. The original settlement of \$92.5 million was given to the Nation through an arm's-length trust fund. Council is responsible for appointing four Trustees on staggered four-year terms. The four Nation Trustees and an Administrative Trustee are responsible for making decisions in the best interest of the Squamish People and managing the investments of the Trust.



On December 10, 2020, Squamish Nation Council approved a \$1.2 million needs-based proposal for Phase 2 of the COVID-19 Community Member Relief Program. Phase 2 focuses on the urgent support and enhanced services needed to keep Elders and most vulnerable members, both on and off-reserve, safe during the pandemic. It also prioritizes areas highlighted by membership in the September 2020 COVID-19 Needs Assessment Survey.

The Nation submitted the \$1.2 million funding proposal to Indigenous Services Canada (ISC) in late 2020, which is intended to provide support for all on and off-reserve members in areas such as:

- Support for Elders;
- Food insecurity;
- Educational and other support for children and youth;
- Mental health assistance and emergency response services (homelessness); and
- Preparedness measures to prevent the spread of COVID-19.

The Community Relief Planning Committee (the Committee) has identified projects in the proposal that could begin immediately. If any of those projects are awarded funding through the proposal, the Committee will meet to reallocate the funds to the other projects.

To prepare the budgets for the proposal, the Committee considered multiple factors including:

- How members on and off-reserve accessed the supports in Phase 1;
- How to make projects inclusive to members both on and off-reserve within travel distance; and
- Targeted supports specifically for off-reserve members.

On April 16, 2020, Council approved the Community Member Relief Program developed by the Committee. Through the beginning of 2020 the Nation received approximately \$1.6 million in funding for pandemic relief. The majority (\$1.49 million) came from ISC with the balance

from generous donations. In addition, Council contributed \$245,000 from their budget to assist Member Services with relief funding.

Phase 1 of the Community Member Relief Program allocated \$1.3 million to projects that supported Members both on and off-reserve through:

- Elder support,
- cleaning supplies and masks etc.,
- meal programs,
- wellness check ins,
- community deliveries,
- assistance with utilities and rent,
- food security,
- emergency shelter for those who have to self-isolate and the homeless,
- emergency operations centre management,
- educational and other support for children and youth,
- virtual community healing,
- and tax preparation for Elders and income assistance.

From June through to September 2020, the Committee met bi-weekly to assess the needs of the community and allocate the remaining funds. The Community Member Relief Program has and will continue to provide support during the COVID-19 pandemic to ensure the health, safety, security and economic well-being of Skwx wú7mesh people and the effective functioning of the Squamish Nation government.

The Nation continues to provide emergency financial support to members in crisis. Members are encouraged to contact 604-982-7610 and request to speak with an intake officer, if they require assistance.

They can also call the Member Services Department to receive emergency assistance and care while isolating due to COVID-19 at 604-982-7610 during office hours or 604-505-3776 after hours.

Special Distribution Update

On December 17, 2020, Squamish Nation Council passed a motion approving distribution of \$1.3 million to the community. Each member will receive approximately \$320 in February 2021.

This special distribution is a share of the one-time payment Squamish Nation received for backrent relating to a Department of Environment lease. Council supported this special distribution, as recommended by the Finance & Audit Committee. These additional funds are intended to ease some of the burdens from this particularly challenging year.

Mortenson Property to be Added to Stawamus Reserve

On December 17, 2020, Squamish Nation Council approved the purchase and sale of the Mortenson Property so that it can be added to Stawamus Indian Reserve No. 24 in Squamish Valley. Council Co-chairs, Kristin Rivers – Tiyáltelut, and Joshua Joseph – Skwetsi7meltxw, were authorized to sign the agreement on behalf of Squamish Nation.

The Mortenson Property (about 21.62 acres of land) is held by Squamish Nation Land Holdings Ltd., which is owned and controlled by the Squamish Nation. A second Band Council Resolution on December 17, 2020 approved that the property be added to Stawamus Reserve.




