2019 BCAFN ELECTION INFORMATION – MALE YOUTH REPRESENTATIVE

The following election guidelines apply to the election for the Male Youth Representative position at the BC Assembly of First Nations Annual General Meeting on September 19, 2019 (“Election Day”) to be held in Vancouver, BC. The deadline to submit a complete Candidate Package is before midnight on August 5, 2019.

ELECTION POLICIES AND PROCEDURES

Candidates are encouraged to review the BC Assembly of First Nations’ Governance Manual. Please contact the BCAFN office via Victoria Austin, Victoria.austin@bcfn.ca or via Maureen Buchan, Maureen.buchan@bcfn.ca to request a copy.

NOMINATION PROCEDURE AND DEADLINE

To nominate a candidate for this position, a member of the BC Assembly of First Nations must complete the Nomination Form and the candidate must complete the Acceptance of Nomination Form. Both must be returned to the Electoral Officer at least 45 days before Election Day (midnight on August 5, 2019).

CANDIDATE ELIGIBILITY

Candidates must:

1. Be a member of a First Nation in British Columbia; and
2. Be a male between the ages of 16 and 29 by Election Day.

CANDIDATE PACKAGE

Candidates or their Nominees must provide the Electoral Officer with the following material:

1. Nomination Form;
2. Acceptance of Nomination Form.

VOTER ELIGIBILITY

Each member of the BC Assembly of First Nations shall have one vote which may only be exercised by their representative as set out on the Membership List or duly registered proxy pursuant to the BCAFN's Governance Manual.

Completed proxy forms may be emailed or faxed to our office no later than Friday, September 6, 2019. After that date, proxy holders must bring the completed proxy form to the electoral officer at least fifteen (15) minutes before the close of each secret ballot poll.

VOTING PROCEDURE

The voting process will be conducted in accordance with the Governance Manual.

Voting shall commence at 8:00 a.m. on Election Day and the first round of voting will close at 10:00 a.m.

Voting shall be done in person by Chief or designated proxy on Election Day.

Once votes have been cast for a particular Band/Nation, there will be no additional or alternate votes accepted from that Band/Nation.

ELECTING MALE YOUTH REPRESENTATIVE

The term of office for the Male Youth Representative will be three years and will require the representative to sign an Oath of Office.

If there is only one candidate for Male Youth Representative, he shall win by acclamation. If there is more than one candidate, an election by secret ballot will be held. The candidate with the most votes shall be considered the winning candidate. In the event of a tie, a second ballot shall be conducted and the candidate with the most votes shall be considered the winning candidate.
