Squamish Nation Independent Review Complete:  
Proposed Woodfibre/FortisBC LNG Project

The Squamish Nation has now completed its independent assessment of the proposed Woodfibre/Fortis BC LNG project. On June 9th and 11<sup>th</sup>, we presented the results of the assessment to membership and discussed how the potential environmental and cultural impacts of the proposed project could be addressed from a Squamish Nation perspective.

As a result of these community meetings, we were able to develop 25 Conditions that Woodfibre LNG Ltd., FortisBC and the province must meet in order for the Nation to consider approving the project.

We would like to present these 25 Conditions to the community on July 20th and 21st - and answer any questions members may have about them.
