Mark Your Calendar | Canada to present \$92.5 M cheque to our Nation

September 15, 2000 | Canada to officially present to Squamish Nation a cheque for \$92.5 million for the Settlement Agreement. Robert Nault, Minister of Department of Indian Affairs and Northern Development will make the presentation to Squamish Nation.

Chiefs and Council wish to extend an invitation to membership to witness this event at a small and brief ceremony that will take place on:

Receiving the \$92.5 million

- > Is only the first step with regard to the Squamish Nation Trust.

Next Step/s

- > Nation Trustee's to complete their tasks outlined in Bulletin No. 14 [For your quick reference see reverse: for workplan and target dates as outlined in Bulletin No. 14, dated August 11, 2000].

Trustees' Work Plan to be Completed by September 22, 2000

- > Attend Training Seminars that will assist them in their tasks.
- > Assess the proposals received from Companies interested in becoming the Administrative Trustee and make a decision on who will be the Administrative Trustee.
- > Call for proposals for an investment manager/s, and
- > Select the investment manager/s.



- > Develop and complete a Survey to membership identifying their priorities for the Comprehensive Plan.
- > And identify membership's questions on what a Comprehensive Plan is.
- > Develop an Investment Policy.

Trustees Work Plan to be completed by October 31, 2000

- > Compile various scenarios of the Comprehensive Plan.
- > Hold information meetings with membership on putting together a Comprehensive Plan for the Trust.
- > Present and communicate the various scenarios to membership for review and feedback.
- > Set a date for a Referendum Vote on a Comprehensive Plan (A plan for managing the money • \$ 92.5 million).

Trustee Work Plan to be Completed Before Christmas 2000

- > Hold Referendum Vote on a Comprehensive Plan.
- > Implement Comprehensive Plan.
- > The payout for distribution included as part of the Comprehensive Plan.
