Elk tags are for eligible Squamish Nation Members with a valid Personal Acquisition License (PAL) and are non-transferable. Elk Tag is allocated for specific Hunting Zones where safety and non-shooting areas must be respected at all times. Poaching continues to be a problem; we are all responsible to co-manage our elk populations in our homelands. All hunters must comply with Compulsory Inspection of harvested Elk, failure to do so will result in ineligibility for future Squamish Nation Elk Draws.
