#### HOUSING ALLOCATIONS

The Squamish Nation Council is proud to share that we allocated 15 homes for this fiscal year on April 17, 2018. Council previously allocated 15 homes in February 2018 to bring the total to 30 home allocations since the election. We are happy for the families and are committed to increasing housing options in our communities.

Housing allocations followed the *Housing Policy* as approved on April 1, 2006.

#### How It Works:

Housing allocations are based on the date of application + category. The four categories are: Elders, Married or Common-Law, Single with Dependents, and Single. Under our current housing allocation program, priority is given to Elders and families, so no houses are allocated to those in the

Singles Category. Your position on one of the four lists changes if you become married, or have children, or become divorced.

If you would like to know where you are on the housing list, you can request this information by contacting the Housing Officer, Heather Baker at 604-982-8607.

Under the Housing Policy, each member, who is allocated a home, is asked to respond to the allocation within 30 days. Then, they visit the Registry Department to choose from the available lots which are currently in Xwmelch'stn (Capilano) in North Vancouver or Wíwk'em (Waiwikum) in Squamish Valley. Once the lots are picked, Council then approves the lot allocation to accompany the housing allocation.

In the coming months, Council will begin supporting the development of a comprehensive Housing Plan that incorporates the numerous surveys and consultations done with Membership over the past ten years. We understand that housing is the #1 priority for our Members and are ready to take bold action to address our housing crisis.

Please stay tuned for work on this critical issue for our people.

## LIVESTREAMING OF COUNCIL MEETINGS

Livestreaming of Council Meetings is a good practice in good governance. It allows for members to watch the discussions and deliberations of the elected Councillors who are put into those roles by our people. Any decision is made on behalf of the People so it is a good practice for the community to see how those decisions are made.

Council previously reported that we would be moving forward with the livestreaming of Council meetings. On April 18th, 2018, Council approved the purchase of livestreaming equipment and services from Livestream.com. Our staff will order the equipment and begin installation as soon as possible. The equipment chosen is also portable and may be used for community meetings, General Meetings, information sessions, and more. We will send out another notice to inform all of when the system will become active, how to access it, and more.

A members-only section of Squamish.net will host the livestream and archives of the video.

Our hope is this move will contribute to rebuilding trust between Council and Squamish People.

Relevant considerations will need to be followed:

- The taping of a Council meeting will be live so all comments may be heard and recorded, so "off the record" or "strike that from the record" comments will no longer work.
- All members or guests who attend a Council meeting will need to understand they are being recorded live and the video will be archived.
- Videos will be archived and stored on our website, on the nation's servers ensuring backup hardiness.
   The hope is these videos will form a considerable basis of material history in the decades to come.

Once live, the Squamish Nation will be one of the few First Nations in Canada that livestreams Council meetings. Through livestreaming, our meetings will be accessible, transparent, and open. We thank you for your patience as we set up this exciting new system.

#### KINDER MORGAN UPDATE

#### **Background:**

Kinder Morgan is an Americanowned public-company formerly known as Enron Liquid Pipelines LLP. Kinder Morgan owns an oil pipeline from Edmonton to Burnaby called the Trans Mountain Pipeline. In 2013, the company applied to the National Energy Board to build a whole new pipeline to transport three times as much oil as the original Trans Mountain pipeline. This would result in a tenfold increase in oil tanker traffic through the Burrard Inlet.

In addition to the above, the new pipeline would exclusively export diluted bitumen — a dangerous product that has been known to sink to the ocean floor. It is potentially even more toxic than conventional crude oil. In the event of an oil spill, it would pose severe risks to our health and safety and could cause catastrophic damage to our inlet and territory.

#### The Nation's Actions

In 2017, the Squamish Nation took legal action to oppose the construction of the pipeline. Our stance was simple:

The British Columbia government and Canadian government approved the request from the American company without adequately consulting the Squamish Nation and addressing our rights as a Nation.

Prime Minister Justin Trudeau, when campaigning in the last federal election, told reporters the National Energy Board which reviews applications for pipelines needed to be overhauled and that it would include the Kinder Morgan project. Once elected, Justin Trudeau has broken this promise.

The Squamish Nation Council is awaiting a decision on the Provincial and Federal court cases. In the Provincial court case, we are seeking a judgement for the courts to throw out the Provincial approval of the pipeline under Christy Clark and the BC Liberals. In the federal case, we have joined together with 13 other First Nations who are also opposing the Federal approval of the pipeline.

When the courts make their decision in either the Provincial or Federal cases, the Squamish Nation may one be given less than 24-hour notice. We will do our best to inform you of the decision as soon as we hear of it.

In the near future, we seek to engage and involve our Members. Kinder Morgan has said they may pull out of this project altogether. We hope to join together with our People, so we can stand up for our lands and future generations together.



Transcription of a statement by Council spokesperson Khelsilem on April 16, 2018 at a News Conference with members of the Tsleil-Waututh Nation, Union of BC Indian Chiefs, City of Vancouver, and City of Burnaby:

"I am here to represent the Squamish Nation and our interests as it pertains to our rights and the rights of our People. This pipeline and these tankers that are to traverse through our people's territories have not met our consent as a nation. The work that is being proposed by the Trudeau government, as well as the proponent Kinder Morgan, contravenes our rights as a people.

We have a right to practice our culture, our way of life, and to continue our right to self-determination in our territories. This is a right that we have never surrendered and never given up. To that end, it is our responsibility as elected leaders to ensure that our territory exists for future generations, that this land was given to us by our ancestors and it is our responsibility as elected leaders to protect that land for our children and their children.

To that end, the Squamish Nation has taken both the Provincial government and the Federal government to court over the flawed, deeply flawed, consultation process.

We have rights as a nation which has not been met or honoured by this government. The Trudeau government ran on promises of changing the relationship with First Nations, and he has completely failed at that regard. He had made numerous promises to our nation and the people of British Columbia, and he has failed at upholding those promises. To that end the Squamish Nation will continue to defend our interests to protect the inlet to protect our territory and to protect the economy that our people rely on within this territory.

We stand together with other First Nations, municipalities, and many, many people of this territory who now live here, to protect our livelihoods, our jobs, and our communities. That is the interest of the Squamish nation; we have done so through the courts, and we will await the decisions from the federal and provincial court cases. but we remain committed to our stance. This project has not been in our interests, and the process the Trudeau government has used carrying on from the Harper government has been a complete failure to the Squamish Nation.

We will continue to fight this; to defend the interests of our people. This is the will of the Squamish people that has been given to us as a sacred obligation as elected leaders by our people, and we will continue to do so based off of that mandate."



#### **GOVERNANCE POLICY**

The Squamish Nation Council received legal advice recommending that its Governance Manual be revised to ensure legality, consistency, conciseness and readability.

Council is proud to announce we intend to proceed with a Squamish Nation membership consultation process regarding the Governance Manual now that this legal review is complete.

Following a Council Motion dated January 25, 2018, Clark Wilson LLP was instructed to proceed with its recommended revisions to the Governance Manual. The initial review looked at broad, high-level issues with the Governance Manual. Clark Wilson LLP has completed a comprehensive analysis as requested.

What was previously called the Governance Manual is now called the Council Governance Policy.

The comprehensive review included recommended amendments that provided: cosmetic edits; revisions to ensure it meets standard legislative drafting practices and conforms to principles of statutory interpretation; and alteration of the title to Council Governance Policy.

#### Next Steps:

Council would like to invite the community to Community Engagement sessions on the Council Governance Policy. We feel it is vital for Membership to contribute to the rules and procedures for their elected Council.

### ELECTION REFORM 2018

Election Reform is a process to review and fix rules for Squamish Nation elections. Squamish Nation elections are run under the 1981 Election Regulations which haven't been updated or fixed since they were first created.

In 2015, Council approved a process to engage Membership on election reform. Since that time, a committee of members was appointed to oversee the engagement, develop a draft election & referendum law, and bring it to a referendum for approval. This committee is called the Squamish Nation Electoral Commission.

In July 2017, a draft law was presented to Council after two years of engagement with Membership. It was the most extensive consultation with Membership in the history of the Squamish Nation. However, the Council of the day denied the request to do a referendum on the law so it could be implemented for the 2017 Council elections.

On April 18th, 2018, Council received a new Terms of Reference and Work Plan from the Electoral Commission.

Council also approved a request from the Commission to set a referendum date on the draft Election and Referendum Law. Council is proud to announce we approved the Election Reform Referendum on December 6th.

2018. The draft law, if supported by our people, will allow for:

- \* Mail-in ballots
- \* Online voting
- \* Longer election period
- \* Candidacy requirements
- \* Campaign finance rules
- \* Single-day voting
- \* Formal appeals process
- \* Council removal
- \* Council size.
- \* Regional representation
- \* Election of Chair
- \* Future of the "Band Manager" role

and much more.

Beginning in May, the Electoral Commission will be coming to the community to present the draft law and receive more feedback than in September start preparing for the Referendum. Stay tuned for notices of these events from the Electoral Commission.



#### **ECONOMIC DEVELOPMENT**

Squamish Nation Council is moving towards separating politics from business. The formation of an Economic Development Group is innovative work started in previous years by Council for which we are grateful.

Many First Nations across Canada have Economic Development Corporations that manage the businesses of the Nation. The Squamish Nation is moving in this direction.

In January-February 2018, Council approved the creation of the Economic Development Group (EDG) called **Nchk'ay Development Corporation**. The name comes from the Squamish story of the Great Flood and is the name of Mount Garibaldi.

Council has appointed Councillors Jacob E. Lewis, Kristen Rivers, and Deanna Lewis as interim board members. In the coming months, Council will begin a search for additional board members from outside the Nation with experience in business, land development, finance, and investment. Council has approved the hiring of an interim CEO to assist in the development of the **Nch'kay Development Corporation** then eventually the board will begin their own hiring process for a CEO of their choosing.

The objective of the EDG is to manage our existing businesses and grow our Nation's business opportunities in a way that reflects our values as a people.

Our existing businesses including the Marina Group, Capilano RV Park, Sqo'mesh Forestry, Nch'ú7mut Construction, and Squamish Valley Gas Bar, will operate under the EDG. New businesses opportunities for the EDG could be in tourism, marijuana, and reserve land developments. Watch for comprehensive reporting and engagement, including opportunities for Members, in the near future.

For the months of February, March & April, I had scheduled classes at Carson Secondary School for grades 8-12 of our Squamish students. Class(es) at 1 hr20min each that took place in room D308, top floor. Week One classes are on Monday, Wednesday and Friday and Week Two fall on Tuesday & Thursday. Average of 15 students for each class.

Lessons consisted of "The Body" parts. Verbally and written on paper. Ouizzes would occur every other class with a "test" to show each students progress. We were gifted some Eagle feathers by Rob Williams this past month so I taught classes how to bead them. Most students had some difficulty with the lesson. This had lasted for maybe 6 classes. One legend, "Syalhmex - Rainman" was taught/ shared by reading in class and then put into play form. In hopes of going to Elders Centre and performing play in front of them.

When our communities have a "Loss" within a Family, I am asked to help with the day's teachings which Victoria Fraser, Bailey's daughter, covers my classes for the day. At this time songs & dances are the lessons of the day. Names, dances and who has brought out fore mentioned. Students will be graded on their knowledge of the history of each song. They will be asked to introduce, sing n dance the song(s).

For the last month and a half, or so, place names of surrounding area of Burrard Inlet will be taught and history of places. Quizzes and tests as usual will be included. All this is taught at Eslha7an as well as I am there every second week, result of Carson's schedule.

I attend Council meetings on a regular basis as scheduled for Tuesdays. When a quorum or pressing issue(s) are pending, I request Victoria to cover classes. Which she does an excellent job doing!! Through the "TRC" many requests come to our Nation through Tracy Williams and/or Lorraine Louis to have any cultural sharing I am asked to provide our "Traditions" with the help of my students. Which we have plenty of.

Monday and Wednesdays were the days I attended our "MAP - Mentor Apprentice Program" 4:00-5:30 taught by Vanessa Campbell.



Council is seeking applicants for four Advisory Committees:

- Elders Advisory
- Youth Advisory
- Budget & Financial Reporting Advisory
- Housing Advisory

Each committee will: have a maximum of ten members, be 100% volunteer, and appointed for a two-year term. Each committee will include two Council members as non-voting liaisons to the committee.

The purpose of the Advisory Committees are to provide advice to Council related to the matter set out by Council.

It is also important to note that Advisory Committees do not exercise authority over Administration, Staff or Council, but may make requests presentations from staff or make requests for relevant information through a request to the Co-Chairs of Council.

Potential goals of the Advisory Committees could be to:

- provide advice on the strategic plans related that issue (elders, youth, etc.);
- to monitor impacts of policies related to the issue;
- or more as to be determined by the Committee in a *Terms* of *Reference* to be approved by Council.

Once appointed, the first order of business will be to appoint a chair of the advisory committee and draft a Terms of Reference which must outline:

- 1. General Purpose
- 2. Key Duties and Responsibilities
- 3. Appointed Members
- 4. Meetings
- 5. Specific Annual Objectives
- 6. Reports and Target Dates

The Chairs of each Advisory
Committee are responsible
for managing the Committee
meetings and reporting to Council.

Committee meeting times, length, and dates are to be determined by the Committee in the Terms of Reference, but are likely once a month for 2 to 2.5 hours.

Conference or Video-conference is an option as well for off-reserve members.

Applicants are asked to submit:

- 1. A Cover Letter (max two pages)
- 2. A Reference Letter related to Committee you are applying to.

Please submit different cover letters if applying for different committees. Please indiciate in your cover letter which committee you are applying.

Council will review applications and appoint Committee members based on: background, experience and interest. Council will strive for a gender and age balance, as well as regional representation of applicants from North Vancouver, Squamish Valley, and those who live away from the community.

- Elder is defined as 55+ from the day they are appointed.
- Youth is defined as 13-30 from the day they are appointed.
