

### **HOW TO VOTE**



## How to Confirm You're Registered to Vote:

- You're eligible to vote if you're a Squamish Member and 18+
- You can confirm you're registered to vote by checking the voters list posted at Chief Joe Mathias Centre and Totem Hall
- You can also register on Voting Day at a polling station: just bring your picture ID and proof of address.

### Our Voting Methods:

Voting Packages will be sent on May 1 by email and post from Chief Electoral Officer, One Feather. You will be able to vote by:

- Mail-in Ballot
- Online May 17-31, www. onefeather.ca/nations/squamish
- In person on May 31

### **SURVEY RESULTS**


226 MEMBERS RESPONDED

### **SURVEY RESULTS**

- 1. Change the number of Councillors?
- 61%: Yes, change the number of Councillors to sixteen (16)
- 16%: No, keep the current number of Councillors at eight (8)
- 23% asked for other numbers: top suggestion 10-12

- 2. Change from 3 ridings to a General Election?
- 85%: Yes, amend the Law to remove the regional seats and allow all eligible voters the ability to vote for all seats on Council
- 15%: No, keep the Law as it is with the three dedicated seats on Council for a North Shore Councillor, a Squamish Valley Councillor and a Regional Councillor.
- 3. Should we allow the Council to choose its Chairperson, or should eligible voters choose the Chairperson by General Election?
- 55% Yes, amend the law so the Council Chairperson is chosen only by the members of Council
- 45% No, keep the Law as it is with all eligible voters being able to vote for Council Chairperson.

- 4A. Limit the number of immediate family members eligible for council, or keep with no limits?
- 90% Yes, amend the Law to restrict the number of immediate family members eligible to be on Council
- 10% No, keep the Law as it is with no restriction on the number of immediate family members eligible to be on Council

- 4B. If we limit the number of immediate family members, should we set a number of allowable immediate family members to 1, 2, or more, who can run for Council?
- 60% Only one (1) person from an "immediate family" should be eligible to be on Council
- 35% Only two (2) persons from an "immediate family" should be eligible on Council
- 5% Only \_\_\_\_ persons from an "immediate family" should be eligible to be on Council.

- 4C. Should we change our definition of 'immediate family'?
- 62% Yes, amend the Law so "immediate family" only includes the mother or father, spouse, brother, sister, son or daughter of a candidate
- 38% No, keep the Law as it is with "immediate family" defined as the mother or father, spouse, brother, sister, son, daughter, niece, nephew, grandparent or grandchild of a candidate

- 5. Should we change the amount of time members or Elders can speak at a People's Assembly?
- 56% Yes, amend the Law to allow a member to speak for up to five (5) minutes
- 26% Yes, amend the Law to allow only Elders to speak for up to five (5) minutes
- 18% No, keep the Law as it is with all members limited to two (2) minutes
