GUIDE to the NOMINATION PACKAGE TO RUN FOR SQUAMISH NATION COUNCIL

In this Guide,

we outline the steps and forms required to become a Candidate for Council:

- 1. Step 1: the Nomination Eligibility Form** - Due Wednesday, July 2, 2025.
- 2. Steps 2-8: The Nomination Package** – Due Tuesday, July 15, 2025.
- 3. Timeline of Important Dates** for Candidates

STEP ONE: NOMINATION ELIGIBILITY FORM EC-1

First, you have to be Nominated by an Eligible Squamish Nation voter, with a Witness.

This form registers your intention to run in the General Election announced May 31.

- **The EC-1 Nomination Eligibility Form is** signed by Yourself, your Nominator, and a Witness.
 - **EC-1 is due** on Wednesday July 2, 2025, by 4:30 pm.

STEPS 2-8: the NOMINATION PACKAGE

STEP TWO: EC-2 Nomination Package Checklist

- Use this checklist to confirm you've got all the forms and support documents complete and included in your printed package.
- Please attach this checklist to the top of your package.
- Your Driver's Abstract, Criminal Record Check, Police Information Check, and Vulnerable Sector Check are included here. Pg 3 has details on getting them.
- Include your professional resume of experience and education, 2pgs.
- Include 2 letters of reference from eligible Squamish Nation voters.

STEP THREE: EC-3 Nominee Acceptance & Oath

- This is the acceptance of your nomination by an Eligible Voter, to run for Council.
- It requires you to sign an oath in front of a notary, and have it notarized.

STEP FOUR: EC-4 Sponsorship Form

- Start collecting signatures of Squamish Nation eligible voters as your Sponsors.
- You need to collect 97 names and signatures on the Regulation Form EC-4.
- They must be registered eligible voters. The voters list to confirm your signees can be found at Totem Hall and Chief Joe Mathias Centre.

STEP FIVE: EC-5 Nominee Autobiography

- This short bio will be used for your campaign during the election.
- Include your background, education, skills, special interests and how you fit into the role.
- Maximum 100 words.

STEP SIX: EC-6 Nominee Election Statement

- A longer written statement that declares which role you are running for and why you want to run for Council. This is your platform, what issues are important to you, what you want to focus on, and what you offer as a Candidate for Council.

Special Note for EC 5 AND 6:

- *You can type or handwrite these statements. Please make it legible.*
- *These statements will be included in the Vote Information Package sent out by the Electoral Commission to all Eligible Voters on August 29, 2025.*

STEP SEVEN: EC-7 Nominee Declaration

- Confirms your contact information
- Ask a witness who is an eligible voter to sign the form and confirm it is correct.

STEP EIGHT: EC-8 Nominee Name Application

- This name will be on the Election Ballot, that you will use to run for Council.
 - This is an optional form, because it is only for candidates that want to use a name other than their legal name for their candidacy.

Details: Getting your Police and Driver's Reports

2A: Three Police Reports

1. **Criminal Record Check,**
2. **Police Information Check,**
3. **Vulnerable Sector Check.**
 - Go to your local police station, to get these 3 reports as soon as possible.
 - You will need 2 pieces of ID – 1 must be government-issued with a photo.
 - Proof of your current address is required.
 - **Criminal Record Checks** can take 2 weeks to process. Request these early.
 - For the **Police Information Check**, you will need a letter from Squamish Nation to give to your local police station. Please contact Member Services for a copy of this letter at membership@squamish.net
 - Request the **Vulnerable Sector Check** from the Police at the same time.

2B: Your Driver's Abstract

- If you have had a valid driver's license in the past ten years, you will need to get your Driver's Abstract from ICBC. It takes 5-10 minutes.
- Go to: <https://onlinebusiness.icbc.com/cli/>
- Select personal driving record, enter 10 years for claim history.
- The report will be emailed to you by ICBC.

Squamish Nation Election and Referendum Law

Eligibility of candidates

- 2.3.1 (a) Subject to this Law, any Squamish member is eligible to hold any elected office and may be nominated as a candidate for, and continue to hold if elected, that elected office if
- (i) that Squamish member
 - (A) is at least 18 years of age on the general voting day in the election for that elected office,
 - (B) is in good standing with the Squamish Nation,
 - (C) is not a commission member or the spouse of a commission member,
 - (D) has not been appointed as voting personnel or is not a member of the immediate family of someone who has been appointed as voting personnel in the election for that elected office
 - (E) is not a nominee for another elected office in the election for that elected office,
 - (F) has not filed for bankruptcy or, if he or she has filed for bankruptcy, has been discharged from those bankruptcy proceedings for a period of at least two years,
 - (G) is not mentally or physically incapable of holding the elected office,
 - (H) has not been convicted of theft, fraud or bribery in any jurisdiction,
 - (I) has not been convicted of an indictable offence involving sexual assault or assault against an individual under the age of 18,
 - (J) has not been convicted of any other indictable offence in the previous 10 years, unless as part of his or her defence in those proceedings he or she reasonably argued he or she was exercising an aboriginal right,
 - (K) has not been charged with an impaired driving offence in any jurisdiction in the previous 10 years,
 - (L) has not ever been removed from an elected office in accordance with 4.3.2(a)(i) [*removal due to ineligibility to hold office*], 4.3.2(a)(ii) [*removal due to repeated absences*] or 4.3.2(b) [*removal due to unbecoming conduct*],
 - (M) has not been found to have committed an offence under this Law or convicted of an offence under any similar election law or referendum law, and
 - (N) has not ceased to be a Squamish member, and
 - (ii) that Squamish member is not engaging in, and has not in the previous eight years engaged in, conduct that is unbecoming a Squamish elected official as defined in section 1.2.1(a)(i) [*conduct that is unbecoming a Squamish elected official*].
- (b) For certainty, a Squamish member who holds an elected office must not, during his or her term in that office, become ineligible to hold that elected office and, if he or she becomes ineligible during that term, is deemed to have resigned from that elected office on the date the event referred to in subsection 0 arises that makes him or her ineligible to hold that office.
- (c) If a Squamish Nation employee assumes an elected office, that Squamish Nation employee must resign his or her employment with the Squamish Nation within 30 days after his or her election to that office.
